<b>Extinguishing media:</b>	Suitable extinguishing media: Dry powder, foam  Unsuitable extinguishing media for safety reasons: No data available.
<b>Special hazards arising from the substance or mixture</b>	Hazards during fire-fighting:  Harmful vapors  Evolution of fumes/fog. The substances/groups of substances mentioned can be released in case of fire.
